**Item No. 9 – Other Events**

Pursuant to the continuing disclosure requirements of the Exchange on Vista Land & Lifescapes, Inc.'s ("VLL" or the "Company"), we hereby disclosed that the Company has raised Php 3 billion from its follow-on offering of Series 2 Preferred Shares listed today, October 4, 2024 at the Philippine Stock Exchange.

The preferred shares were offered to the public from September 16 to 25, 2024. The initial dividend rates for the Series 2A Preferred Shares (VLL2A) and Series 2B Preferred Shares (VLL2B) are 7.9892% p.a and 8.4000% p.a, respectively.

The proceeds of the offer shall be used to refinance existing indebtedness, purchase, develop, construct or improve assets, property or equipment, and for general corporate purposes.
